Sustainability Policy

This Policy applies to all employees, agents and consultants acting on behalf of Biogen, and its affiliates worldwide.

- Set goals, objectives and targets to implement our strategy, including the adoption of relevant standards, principles and guidelines
- Manage our environmental footprint responsibly
- Develop solutions that address environmental and social challenges for our customers and society
- Assure our products are safe for their intended use through their entire lifecycle
- Assure the appropriate management of any Biogen health and safety issues that may touch customers, neighbors and the public
- Maintain a safe and healthy workplace
- Satisfy our customers with superior quality and value
- Report publicly on our sustainability performance and share our performance and management practices with interested stakeholders to promote adoption of successful methods
- Support local needs and education in communities where Biogen employees live and work
- Conduct our business with uncompromising honesty and integrity
- Perform due diligence on mergers and acquisitions

Key Principles

This Policy is guided by three strategic principles that make sustainability implicit in everything we do:

Business Success

Operating with ethics, integrity and accountability is, and will always be, integral to our success. As part of our efforts to build long-term value for our shareholders, we will continually invest in research and development to discover new therapies.

Environmental Stewardship

Recognizing that the development, manufacture and distribution of our products use natural resources, consume energy and generate waste, we must continually work to minimize these impacts across our enterprise.

Social Responsibility

Addressing some of the greatest unmet medical needs; providing educational and other support services for our patients; offering a supportive and challenging work environment to our employees; and giving back to the communities where we live and work, all of which are integral to Biogen 's culture. We believe in the value of engaging key stakeholders in dialogue and taking action to improve our sustainability performance.

Implementation

Corporate

Biogen's Corporate Governance Committee of the Board of Director's has the overall responsibility for endorsing the Sustainability Policy.

The Biogen Corporate Sustainability Council Executive Committee is responsible for setting the sustainability vision and strategy for the organization and overseeing the implementation of the strategy.

Management

Management is responsible for ensuring that the Policy is adhered to and supervising the implementation of the strategy and any associated training programs. The Biogen Sustainability Leadership Committee is responsible for managing the implemenation of our corporate sustainability initiatives and championing sustainability improvements among employees and other stakeholders.

Biogen will perform an annual gap analysis of our sustainability practices and programs, and adjust our strategy as necessary.



Operational

As stated in Biogen's Environmental, Health and Safety Policy, we will develop and manufacture therapies, as well as design, build and operate our facilities in ways that maintain a safe and healthful workplace; conserve energy, water and raw materials; and prevent harm to public health and the environment.

We will establish and maintain effective procedures and systems to adhere to the principles of this Policy and track progress against our sustainability strategy.

Employees

Employees are required to adhere to this Policy and are responsible for implementing the sustainability strategy. This includes incorporating sustainability considerations into decision-making to best serve our patients, their caregivers, the community, the environment and our Company.

Communication

Biogen will communicate this Policy to all employees. We will also annually report our performance to our stakeholders.

Regulatory and Enforcement

Biogen will comply with all applicable local, regional and national laws and regulations concerning sustainability. Where appropriate and feasible, we will set operating standards that exceed legal requirements.

Failure to follow the principles and steps set out in this Policy may result in disciplinary action, up to and including termination.
